### **Proceedings**

### Concerns of district:

A customer from the Pioneer Water District Kevin Ramey addressed the Board with several concerns about the Water Treatment Plant that is currently under construction. Mr. Ramey stated that he had been following the Water Treatment Plant Project since January of 2017. Kevin Ramey questioned the Board about concerns regarding the feasibility while Pioneer is currently purchasing water from the City's of Westminster and Seneca. Mr. Ramey stated that the rate payers would be burdened if Pioneer continued to construct the Water Treatment Plant. Mr. Ramey also vocalized concern about the possibility of high rates customers would have to pay. Mr. Ramey discussed what has already been spent on the Water Treatment Facility. Mr. Ramey presented to the Board a copy of numbers prepared by Brad Hobbs concluding the Water Treatment Plant would cost an additional seventeen million dollars to construct and operate over a forty-year period. The document prepared by Brad Hobbs contradicts the feasibility study which had been provided to Pioneer by Design South Professionals determining the need for a Water Treatment Plant to be added to Pioneer's waterworks system.
