Approval of Minutes: Eddie Grant made a motion to accept the Board meeting minutes as written from May 11, June 27, July 11 and also Nomination minutes from May 11. Jerry Barlow seconds the motion. All in favor, motion carried.

Old Business: Terry Pruitt read Judge R. Lawton McIntosh's ruling from the trial. The Judge ruled as a matter of law, that because the City of Westminster is not a customer of Pioneer, it has no standing to sue Pioneer as part of this case. The Judge ruled, as a matter of law, that the enabling statute for Pioneer does allow Pioneer to construct and operate a water treatment facility as part of its waterworks system, with or without a showing of necessity; the decision on this point is up to the discretion of the Pioneer Board. Judge McIntosh asked for briefing on two main point which will be due in thirty days. The first was whether the plaintiff was seeking equitable relief or a legal remedy and second Judge McIntosh wants briefings on what impact should Pioneer's technical violations of the notice requirements under the statute have on whether Pioneer can continue to build the water treatment facility and what impact does the subsequent effort to "cure" that original notice defect have on this issue.
