Old Business: Donald Philips presented to the Board a Modification to Agreement Start-Up Assistance and activities for the Water Treatment Plant with Design South in the amount of forty-nine thousand and five hundred (\$49,500.00) dollars. Followed with discussion.

Ronnie Williams made a motion to accept and sign the Design South Modification agreement. Jerry Barlow seconds the motion. All in favor, motion carried.

Donald Phillips presented a Technical Memorandum to the Board for an installation of a Bulk Carbon Feed System that will enable Pioneer Rural Water District to treat MIB and Geosmin. The Bulk Carbon Feed System is estimated to cost three hundred seventy-five thousand dollars (\$375,000.00). Mr. Philips proposed that the treatment improvements should provide Pioneer Water District with a high quality, taste, and odor free, finished water.

Jerry Barlow made a motion to accept and move forward with the construction of the Bulk Carbon Feed System located at the Raw Water Pump Station. Eddie Grant seconds the motion. All in favor, motion carried.
